1. We hereby declare that the article provided:

US010TNN (POLYPROPYLENE, PLASTIC)

complies with the following European Union (EU) legislation:

- (EC) Regulation No. 1935/2004 and subsequent updates and amendments,
- (EU) Regulation No. 10/2011 and subsequent updates and amendments,
- (EC) Regulation No. 2023/2006 and subsequent updates and amendments,
- 2. The article in question is manufactured with the following basic components:
- PLASTIC (THE SIDE WHICH IS IN CONTACT WITH FOOD).
- 3. i) Types of food products with which the article is intended to come into contact: **FOR ALL FOOD TYPES.**
 - ii) Temperature and storage time in contact with the food product:

THE ARTICLE WAS TESTED FOR GLOBAL MIGRATIONS AND SPECIFIC MIGRATIONS, SIMULATING THE WORST CASE SCENARIO CONTACT CONDITIONS.

- iii) Ratio between the contact surface of the food product and the volume used to determine the conformity of the article: **6** dm²/kg.
- 4. With regard to the article in question, compliance with the Global Migration limits is declared (Test conditions: 40°C for 10 days).
- 5. With reference to the **Declarations of Conformity**, **issued by our suppliers on the raw material and auxiliary materials** used, we declare:
 - There are substances subject to restrictions by current legislation in the article in question. The aforementioned substances are listed in Table 1.

- to comply with the provisions established in Art. 15 of (EC) Regulation n. 1935/2004 and subsequent amendments with regard to labelling;
- to comply with the provisions established in Art. 17, of the (EC) Regulation n. 1935/2004 and subsequent amendments with regard to traceability.
- 10. In support of the foregoing, the company declares to have the declarations of conformity of the suppliers of raw material and auxiliary materials readily available for the competent Authorities.
- 11. This declaration is valid from the date shown below and will be replaced if substantial changes take place in the production of the article in question which may change certain essential requirements for compliance or when the legislative references cited in this declaration are modified and updated in order to request a new verification for compliance purposes.
